We are seeking your support to help Macon County CASA continue to advocate for local children in foster care. In 2021, there were over 630 cases of abuse and neglect to children in Macon County. CASA has served over 440 of these children with 280 volunteer advocates. Your sponsorship helps CASA provide advocacy to more local foster children so they can have a safe and permanent home.

Also in 2021, Macon County CASA expanded our services to offer advocacy to foster children in DeWitt County! We are currently advocating for 10 of the 50 local foster children in DeWitt with 6 DeWitt County volunteer advocates.

As continued additions for this 20th year, the fun starts in February when community members will have an opportunity to vote online for their favorite **Casas for CASA** Playhouse designs. BLDD architects will vie to win the contest for the most kid-friendly and creative designs. Then...

- **THREE** finalists will be chosen from the voting! CASA is building a third house JUST for our DeWitt County expansion!
- JDM Custom Construction, McClanahan Builders, Doug Davidson Construction, and members of the Metro Decatur Home Builders Association will construct the three winning playhouses in the St. Paul's Lutheran Church warehouse. Professional painters, Hartwig & Callarman Painting Co., will be painting a house; staff from 121 Coffee Run will also paint a house under the professionals' guidance; and Trent Painting Service will be professionally painting the third and final house.
- Community members' **first chance** to purchase tickets online via [www.maconcountycasa.org](http://www.maconcountycasa.org) is Monday, March 21st, at 8 a.m.

- Tickets will be sold online and throughout both communities from March 21st-June 9th, when the winning tickets will be drawn **LIVE** in both Decatur and Clinton. Throughout the duration of ticket sales, the playhouses will be housed in downtown Decatur at Central Park and in downtown Clinton at the Mr. Lincoln Square for children and community members to view!
